Waiting List Application - Information Sheet

Wishart Christian Village is an independent living retirement village for Christian retirees of the age 65 and over and is owned and operated by Wishart Christian Village Association Inc.

Wishart Christian Village Association Inc. is an Incorporated Association and a registered charity. It is governed by its Constitution, the Associations Incorporation Act 1981 and, as a scheme operator of a registered Retirement Village, the Retirement Villages Act 1999. Persons applying for inclusion on the waiting list are encouraged to become members of the Wishart Christian Village Association. Membership is not a requirement for inclusion on the waiting list. However, this will become necessary once residency is taken up. As stated in the **Residency Agreement** for Wishart Christian Village, all residents in the village must become members of the Association:

MEMBERSHIP OF ASSOCIATION

16.1 While the owner of the Retirement Village Land or the Scheme Operator is Wishart Christian Village Association Inc, the Resident must become a member of Wishart Christian Village Association Inc. upon becoming a resident of the Retirement Village.

(WCVA Inc. Constitution November 2013)

For this reason, applicants for inclusion on the waiting list need to ensure that they are eligible to become ordinary members of the association. An ordinary member is defined in the **Constitution**:

ARTICLE 5. MEMBERSHIP

(1) Ordinary Membership

A person shall be eligible for ordinary membership of the Association by subscribing, in writing, to the Word of God as interpreted by the Westminster Confession, the Belgic Confession, the Heidelberg Catechism or the Canons of Dordt.
