## Application for Membership - Information Sheet

Wishart Christian Village Association Inc. is an Incorporated Association and a registered charity. It is governed by its Constitution, the Associations Incorporation Act 1981 and, as a scheme operator of a registered Retirement Village, the Retirement Villages Act 1999. The Association is the owner and operator of Wishart Christian Village which is an independent living retirement village for Christian retirees of the age 65 and over.

### Objects of the Association.

#### ARTICLE 2. OBJECTS

- (a) To provide in a Christian environment for the housing, accommodation, maintenance and welfare of men and women of Christian faith, irrespective of denomination and financial circumstances.
- (b) To encourage, promote and assist with the organisation of religious services and meetings, in accordance with practices as interpreted by the Westminster Confession, the Belgic Confession, the Heidelberg Catechism or the Canons of Dordt.
- (c) To encourage and promote the wider circulation, understanding and practical application of the Holy Scriptures, in accordance with practices as interpreted by the Westminster Confession, the Belgic Confession, the Heidelberg Catechism or the Canons of Dordt.
- (d) To promote and publicise the work, projects and activities of the Association.
- (e) To conduct and operate all activities, projects and undertakings of the Association on the basis that there shall be no pecuniary gain or benefit to the members of the Association.

### Membership of the Association.

#### ARTICLE 5. MEMBERSHIP

##### (1) Ordinary Membership

A person shall be eligible for ordinary membership of the Association by subscribing, in writing, to the Word of God as interpreted by the Westminster Confession, the Belgic Confession, the Heidelberg Catechism or the Canons of Dordt.

##### (3) Associate Membership

A person shall be eligible for Associate Membership of the Association if he has a bona fide interest in the objectives of the Association but is not able to comply with Clause 5 (1). Associate members shall have no voting rights.
